



Trico Homes 2022 Anniversary Gift Contest – Official Rules & Regulations

CONTEST PERIOD

The Contest entry period starts at 12:00 pm (MDT) on Monday, March 21, 2022, and ends at 11:59 pm (MDT) on Saturday, December 31, 2022 (Contest Period). All entries received after this time period will be considered invalid. There will be one (1) winner chosen per month, from entries received within that calendar month. The draw will take place on the first Monday of the month following (e.g., March draw will be on Monday, April 4, 2022.) The final Contest draw date will be at 9:00 am (MDT) on Monday, January 2, 2023. Trico Homes reserves the right to extend or shorten the Contest at their sole discretion.

ELIGIBILITY

The Contest is open to all residents of Canada who have reached the legal age of majority in their province/territory of residence. Employees, representatives, or agents (and those domiciled with any such employee, representative or agent) of Trico Homes, their parent, affiliated and related companies, the consulting, advertising, and promotion agencies of the Sponsor (collectively, the “Contest Parties”) and/or any of the Prize Providers (defined below), are not eligible to enter or participate nor win a Prize (defined below) in the Contest. The Contest is not open and void where prohibited by law.

HOW TO ENTER

Customers who purchase a New Trico Home during the Contest Period will automatically be entered to win. Each purchase will receive one (1) entry into the draw.

NO PURCHASE NECESSARY. To submit an entry without purchasing a New Home, entrant may send a FREE request in writing, including: (a) the entrant’s first name, last name, email address, and phone number; and (b) a statement indicating the request is for: (i) one (1) Entry on a plain white piece of paper by mailing the fully completed request (in an envelope with sufficient Canadian postage) to: Trico Homes 2022 Anniversary Gift Contest, Attn: Marketing Department, #100, 7711 Macleod Trail SW, Calgary, AB T2H 0M1 (collectively, a “Entry Request”). Upon receipt of an Entry Request in accordance with these Rules, the entrant shall receive one (1) entry into the Contest. To be eligible, Entry Requests must be postmarked during the Contest Period and received by December 17, 2022. Limit of one (1) Entry Request per person. Trico Homes is not responsible for late, lost, stolen, misdirected, delayed, incomplete, damaged, destroyed, late or illegible Entry Requests (all of which are void).

WINNER SELECTION

One (1) winner will be chosen each month, during the contest period, on the first Monday of the month. Winners will be contacted by phone or email. Each entrant is responsible for monitoring his/her email and phone for prize notification. If a potential prize-winner cannot be reached by Trico Homes within five (5) business days of the draw date, using the contact information provided at the time of entry, or if the email is returned as undeliverable, that potential prize winner shall forfeit the prize. Trico Homes will then draw another winner. Winners must correctly answer a skill testing question.

PRIZES AVAILABLE

There will be one (1) winner chosen each month. Winners may choose one (1) of the following prizes.

- i) \$3000 Design Centre Upgrade* (the “Design Centre Prize”). No cash value. Non-transferable. Must redeem within 10 business days of winning. Winner may choose any upgrade(s) available at Trico Homes’ Design Centre up to the retail value of \$3000 CAD. Be advised that some items currently on display may not be available due to current market supply; in this case, reselections will be required.
- ii) \$3000 Westjet Gift Card (the “Westjet Prize”). No cash value. Non-transferable. Winner will receive a Westjet e-Gift Card, equivalent to \$3000 CAD.
- iii) \$3000 Any Home Option* (the “Home Option Prize”). No cash value. Non-transferable. Must redeem within 10 business days of winning. Winner may choose any Home Option available to the applicable home model purchased, up to the retail value of \$3000 CAD. If a Home Option worth more than a \$3000 retail value is chosen, winners are responsible for paying the additional amount.

*Design Centre & Home Option prizes are dependent on stage of home construction, and not applicable to pre-built (i.e., Quick Possession and Showhome) home sales.

GENERAL RULES

Each Prize claim is subject to verification by Trico Homes. Entries made with multiple addresses, under multiple identities, or through the use of any device or artifice to enter multiple times or entries that are in excess of the permitted number of entries during the Contest Period are automatically void. All Contest entries obtained through unauthorized sources, or which are incomplete, illegible, mutilated, altered, reproduced, forged, irregular or fraudulent in any way or otherwise not in compliance with these Rules are automatically void. Trico Homes will be the sole and final reference source in validating a Prize claim.
